

### **Bob Chapman** Chairman of the Board and CEO **Barry-Wehmiller**



Recently named the #3 CEO in the world in an Inc. magazine article, Bob Chapman is very intentional about using his platform as Chairman and CEO of Barry-Wehmiller to build a better world.

He became the senior executive of the organization in 1975 at age 30, when the 90-year-old business had \$20 million in revenue, outdated technology and a very weak financial position. Despite the obstacles, Bob applied a unique blend of strategy and culture, and since, has led Barry-Wehmiller through more than 115 successful acquisitions.

Over the past two decades, a series of realizations led him away from traditional management practices to a people-centric style, which he calls Truly Human Leadership - an approach with the goal of making team members feel valued, cared for and that they are an integral part of the company's purpose. At Barry-Wehmiller, there is a unique measure of success: by the way we touch the lives of others.

Bob's experiences and the cultural transformation he championed were the inspiration behind his Wall Street Journal bestseller Everybody Matters: The Extraordinary Power of Caring for Your People Like Family. The book is co-authored by Raj Sisodia, founder and co-author of Conscious Capitalism. In 2013, Bob and his wife, Cynthia, launched a nonprofit, Our Community Listens, to bring the company's groundbreaking Listen Like a Leader training to communities at no charge. And, in 2015, the Chapman & Co. Leadership Institute was founded to bring Barry-Wehmiller's trademark culture transformation and leadership training to for-profit organizations.

Bob regularly writes about the powerful intersection of people-centric leadership and good business strategy on his blog, TrulyHumanLeadership.com. In 2016, Harvard Business School released a case study illustrating how Barry-Wehmiller applies its people-centric approach to business decision-making.

Bob's speaking engagements include the Aspen Ideas Festival, Conscious Capitalism events, the ScaleUp Summit, TEDxScottAFB, the 2016 US Congressional Retreat, the Danforth Center's Seeds of Change, WorldBlu, the CEO Global Leaders Forum, the American Conference on Physician Health, the Institute for HealthCare Consumerism Forum, the Shingo Prize for Manufacturing Excellence, the HERO Forum for Employee Health Management and others.

Bob shares his leadership journey and the story of Barry-Wehmiller whenever he can to offer an example of the way businesses and organizations should be: focused on creating value for all stakeholders - team members, customers, communities and shareholders. Not only is it the right thing to do, it creates meaning and fulfillment for team members.

Bob has a Bachelor of Arts from Indiana University Bloomington and a Master of Business Administration from the University of Michigan. He spent his early career as an accountant with Price Waterhouse.

### **Gene Toombs**

Chairman Emeritus, Former Chairman, President and CEO MiTek

Gene Toombs III, named Chairman Emeritus of MiTek immediately following his retirement, exceptionally served as the former Chairman, President and CEO of MiTek Industries, Inc. from 1993 through 2012. Toombs was instrumental in the sale of the majority of the company to Berkshire Hathaway in 2001. The business grew dramatically during his tenure. Today, MiTek delivers software, services, engineered products, and automated solutions that enable the building industry to improve efficiencies by optimizing the balance between off-site and on-site.

Toombs strongly believed in giving back to causes he believed in. He chaired the boards of St. Luke's Hospital, Junior Achievement of Greater St. Louis, and the St. Louis Science Center, and served as a trustee for Webster University and the Missouri Botanical Garden. Toombs was a director for the Central Institute for the Deaf, the Regional Business Council and a member of the President's Council for The Magic House in St. Louis. He also supported the Auto Club Enterprises (AAA), St. Louis Trust Company, and Duke Manufacturing as a corporate director.

A native of New Jersey, Toombs lived and worked in St. Louis for over 40 years. He graduated from Fairleigh Dickinson University with a degree in Business Management and The Harvard Business School's program for Management Development.

He and his wife, Judy, have one son, Gene Toombs IV, daughter-in-law, Lynn, and two grandchildren residing in St. Louis, MO.

# **CLASSROOM PROGRAMS**

Junior Achievement provides positive and impactful online and in-class resources to teachers and parents. We offer over 58 JA programs for kindergarten through high school students in Missouri, Illinois, and Indiana. During the pandemic stay-home period, our team excelled with remote learning; helping educators and volunteers deliver JA curriculum through various on-line platforms. We didn't slow down on our outreach, and this past school year we reached over 154,000 students with over 1/3 engaged with remote learning. We have a significant role today reaching students with our programs virtually, with our hard-copy material, and through a combination of both.



### ELEMENTARY SCHOOL PROGRAMS

Junior Achievement's Elementary School Programs are the foundation of our K-12 curricula. Six sequential themes, each with five hands-on sessions, as well as an after-school and capstone experience, work to change students' lives by helping them understand business and economics. Volunteer consultants from the local community lead students in engaging activities. The volunteers serve as role models and enrich the activities with their own life experiences.



### MIDDLE SCHOOL PROGRAMS

Junior Achievement's Middle Grade Programs build on concepts the students learned in our Elementary School Programs. These programs are designed to help teens make difficult decisions about how to best prepare for their educational and professional future. They supplement standard social studies curricula and develop communication skills that are essential to success in the business world. Each week, for 6 weeks, business volunteers serve as role models, lead discussion and guide students through engaging activities. They enrich the program with their own experiences and business knowledge.

### HIGH SCHOOL PROGRAMS

Junior Achievement's High School Programs include economic and business curricula, an after-school student-led enterprise, and a capstone experience. The dynamic interaction between JA volunteers and students promotes active learning and brings theory to life. The volunteers bring real-life business experience and guidance into the classroom at a time that represents an essential crossroads for young people.



### JA Finance Park<sup>®</sup>

JA Finance Park® is an economic education program for 7th through 12th grade students, which introduces concepts centered around personal finance, decision making, and career exploration. There are two levels: Entry (for middle schools) and Advanced (for high schools). The program consists of teacher-led classroom lessons and activities, student self-guided curriculum or a blended model of both, followed by an interactive simulation.





The JA Finance Park® Virtual simulation is a fully redeveloped, hands-on budgeting program. It is an eye-opening experience where students are assigned life-like scenarios that challenge them to make difficult financial choices while maintaining a budget. Students build a foundation upon which they can make intelligent economic decisions that last a lifetime, including those related to employment, education, income, expenses, savings, credit, risk management and more!

On-site, JA Finance Park® is designed as a collaborative marketplace representative of the local business community, including financial services, education, insurance, entertainment, communications, utilities, and more. In this tablet-based program, students explore and learn about different budget categories, create a budget, make purchasing decisions, and pay for their expenses.



### Achievement Investor Sponsors










Percentage of JA STL Alumni who said that the greatest impact Junior Achievement had on their lives was helping them understand how business works.





### JUNIOR ACHIEVEMENT CELEBRATES OVER100 YEARS OF CONTINUOUS OPERATION




Junior Achievement was founded in 1919 in Springfield, Massachusetts by business leaders Horace Moses, founder of Strathmore Paper Company, and Theodore Vail, Chairman of AT&T, and with the support of Murray Crane, U.S. Senator from Massachusetts. The original purpose of JA was to help teens moving from rural America to the industrial cities gain the skills they would need to be successful adults.



JA of Greater St. Louis started in 1943 with a single after-school program for high school students. Today we have over 58 different programs for students kindergarten through high school, and a 39,000 square foot facility that operates three different education simulators. Throughout that time, we have remained steadfast in our dedication to preparing young people to succeed in their future.

A decade ago we provided programs to more than 117,000 students throughout Missouri and Southwestern Illinois. In 2016, we added our 6th district with JA in The Wabash Valley located in Indiana.

Today we reach over 150,000 students across 144 counties in three states. Our continuous improvement plan has helped students stay in school, commit to obtaining advanced degrees, and add to the local economy by starting their own businesses. We are helping kids turn their dreams into plans for their future success.


